



Naše kolegice iz JPM & Partners kancelarija u Podgorici – Amra Ademović i Alma Karađuzović Đindinović, su prisustvovalе obuci pod temom „Pružanje pravne pomoći i zaštita žrtava trgovine ljudima“ koja se održala u periodu 17 – 19. januar 2024. godine u Budvi, u organizaciji i pod pokroviteljstvom Savjeta Evrope – kancelarija u Podgorici, Advokatske komore Crne Gore, Centra za obuku u sudstvu i državnom tužilaštvu i Ministarstva pravde Crne Gore.

Our colleagues from JPM Partners/ office in Podgorica – Amra Ademovic i Alma Karadzovic Djindjinovic, attended the training under the theme “Providing legal assistance and protection of victims of human trafficking” which took place in the period 17-19 January 2024 in Budva, organized and under sponsorship of the Council of Europe - office in Podgorica, the Bar Association of Montenegro, the Center for Training in the Judiciary and the State Prosecutor’s Office and the Ministry of Justice of Montenegro.

Obuka je imala za cilj sagledavanje pravnih aspekata vezanih za identifikaciju, pomoć i zaštitu žrtava trgovine ljudima sa posebnim osvrtom na sljedeće teme:

- **Zaštita žrtava, posebno djece kao ranjive kategorije**

Zaštita djece u kontekstu trgovine ljudima zahtijeva poseban pristup te zakoni i prakse trebaju posebno uzeti u obzir potrebu zaštite djece od bilo kojeg vida eksploatacije, pa ovo uključuje i edukaciju profesionalaca o specifičnim potrebama djece žrtava trgovine ljudima

- **Unaprjeđenje zakonskog okvira**

Ovdje se stavlja akcenat na pooštavanje kazni za trgovinu ljudima, pružanje dodatnih prava žrtvama i jačanje mehanizama zaštite

- **Stručne službe**


Organizacije koje pružaju pomoć žrtvama trgovine ljudima često rade u saradnji sa stručnjacima različitih profila, uključujući pravnike, socijalne radnike, psihologe i medicinsko osoblje te u tom smislu unaprijediti i organizovati što bliskiju saradnju

- **Iskustva i praksa u Hrvatskoj i Srbiji**

Hrvatska i Srbija, kao članice Evropske unije ili kandidati za članstvo, obavezane su usklađivanju svojih zakona i praksi sa evropskim standardima te iskustva i praksa u ove dvije zemlje mogu se pratiti kroz izvještaje državnih tijela, NVO i međunarodnih organizacija

- **Praksa Evropskog suda za ljudska prava**

Odluke Evropskog suda za ljudska prava mogu pružiti smjernice o tome kako se primjenjuju ljudska prava u kontekstu trgovine ljudima i ove odluke često postavljaju standarde za zaštitu žrtava i obaveze država.



The training aimed to review the legal aspects related to the identification, assistance, and protection of victims of human trafficking, with a special focus on the following topics:

- **Protection of victims, especially children**

Design and implement comprehensive protection measures tailored to the specific needs of child victims, considering their psychological, social, and educational needs. Collaborate with child protection agencies/ other relevant stakeholders to create a supportive network for victims.

- **Improvement of the Legal Framework**

Advocate for stronger penalties for traffickers and legal measures that prioritize the protection and rights of victims.

- **Professional Services**

Foster collaboration between legal professionals, social workers, healthcare providers, and NGOs to create a multidisciplinary approach to addressing human trafficking cases. Establish counseling and rehabilitation services to help victims reintegrate into society and overcome the trauma associated with trafficking.

- **Experience and practice in Croatia and Serbia**

Croatia and Serbia, as members of the European Union or candidates for membership, are obliged to harmonize their laws and practices with European standards, and the experiences and practices in these two countries can be traced through the reports of state bodies, NGOs, and international organizations

- **European Court of Human Rights (ECHR)**

Stay informed about ECHR decisions related to human trafficking cases to understand evolving legal standards and interpretations and use ECHR jurisprudence to advocate for stronger legal frameworks and better protection mechanisms at the national level.
